NOTIFICATION

Revision of rates for Blood Processing Charges under West Bengal Health Scheme

The approved rates for processing charges on different components of human blood were fixed and notified under No. 796-F (MED) dated 19/09/2013 for all empanelled hospitals except TMC, Rajarhat and No. 176-F (MED) WB dated 19/09/2022 for TMC, Rajarhat only.

In case of transfusion of blood, cost of some procedures could not be settled for reimbursement by the Hospitals as well as the beneficiaries since the approved lists as notified earlier were not exclusive.

Besides, it was also under active consideration for some time past to revise the existing rates for processing of different components of blood up to the extent of ceiling fixed by Ministry of Health and Family Welfare Department, Government of India.

Now, after careful consideration of all aspects, the Governor is pleased to introduce some new procedures and to revise some existing rates in relation to blood transfusion as per following table:-
