
Cost of OPD (Out Patient Department) treatment of fifteen diseases as listed under Clause-7(1) of the 'West Bengal Health for All Employees and Pensioners Cashless Medical Treatment Scheme, 2014' (WBHS) are reimbursable under the Health Scheme.

Considering the gravity of the disease, the WBHSA has agreed to include "Ankylosing Spondylitis" as the sixteenth disease in the OPD list under clause 7(1) of WBHS.
